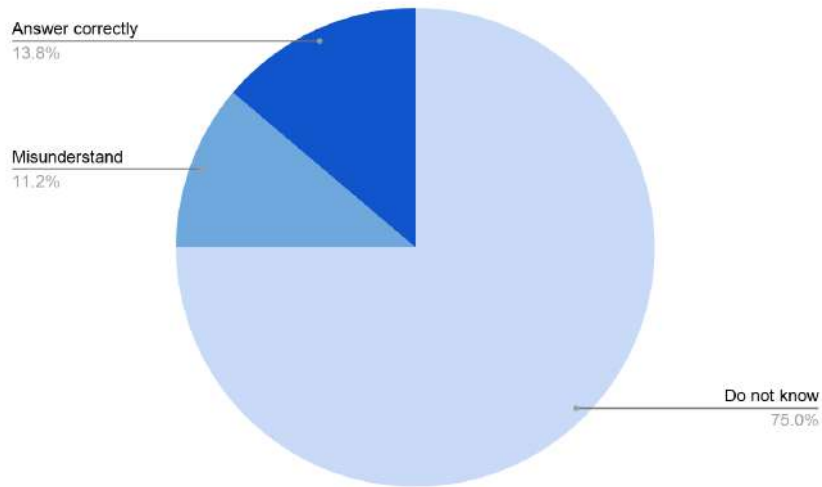

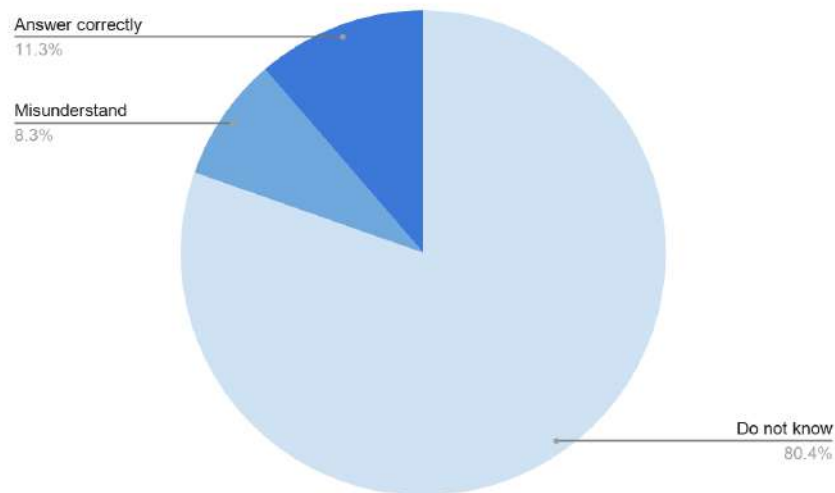
## 1. Awareness of Stockholm Convention, U-POPs, and BAT/BEP

*i.* Stockholm Convention aims to protect human health and the environment and addresses what environmental problems?



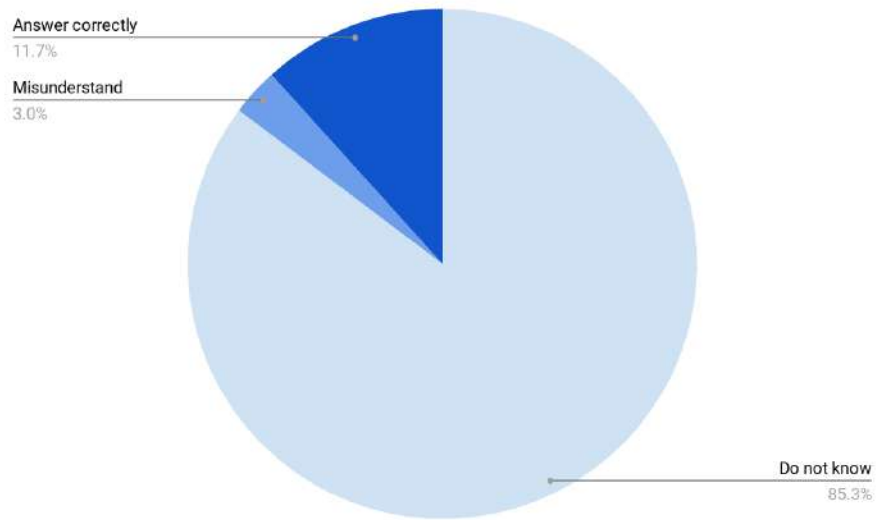

*ii.* How is the scrap metal industry related to the Stockholm Convention?



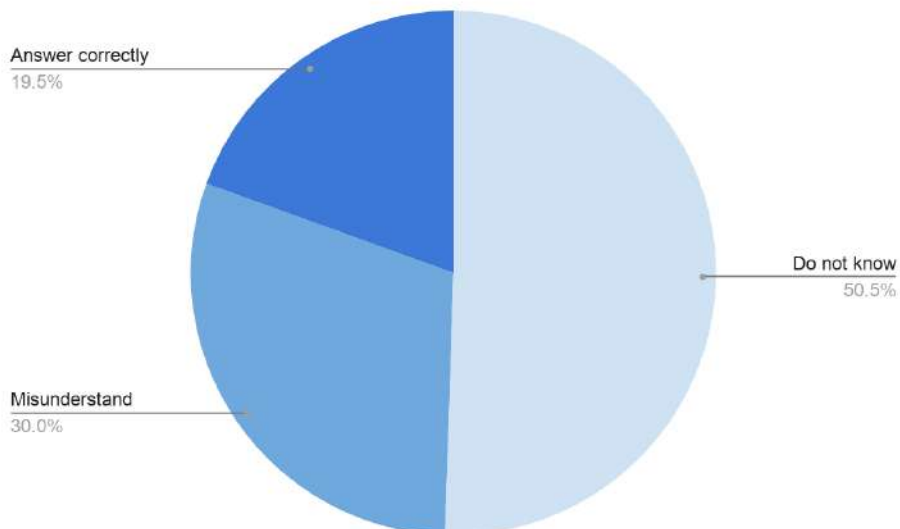

iii. Which unintentionally-released persistent organic pollutants (U-POPs) that Stockholm Convention aims for the scrap metal industry to reduce?



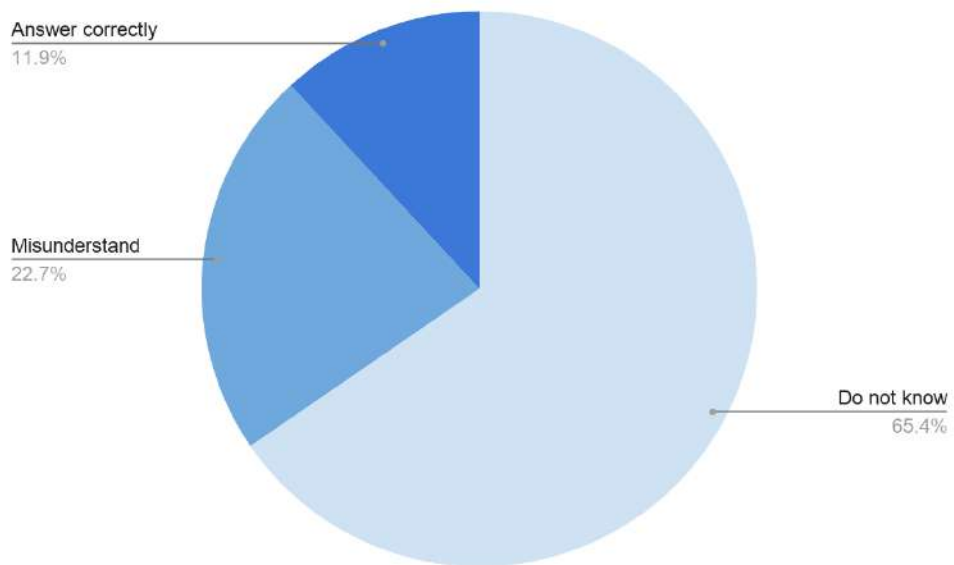

iv. Persistent organic pollutants are harmful to human health because...



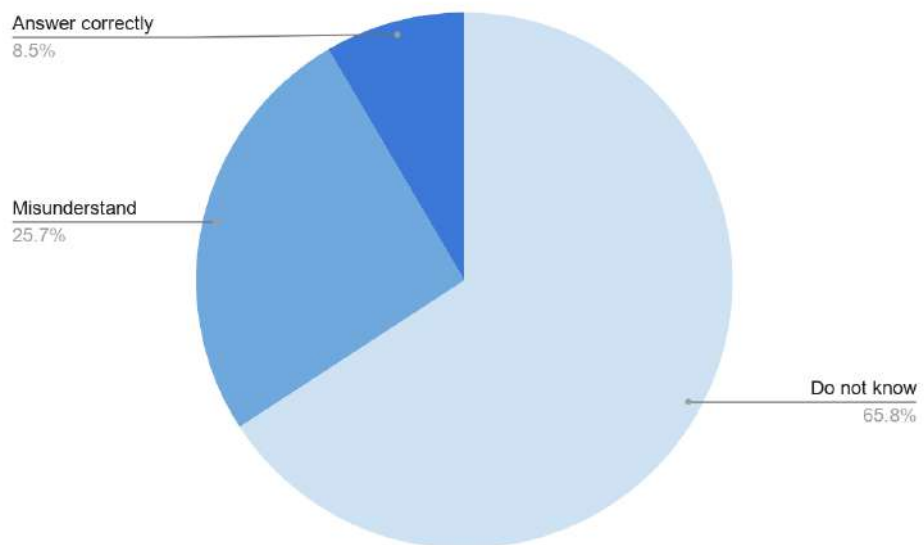

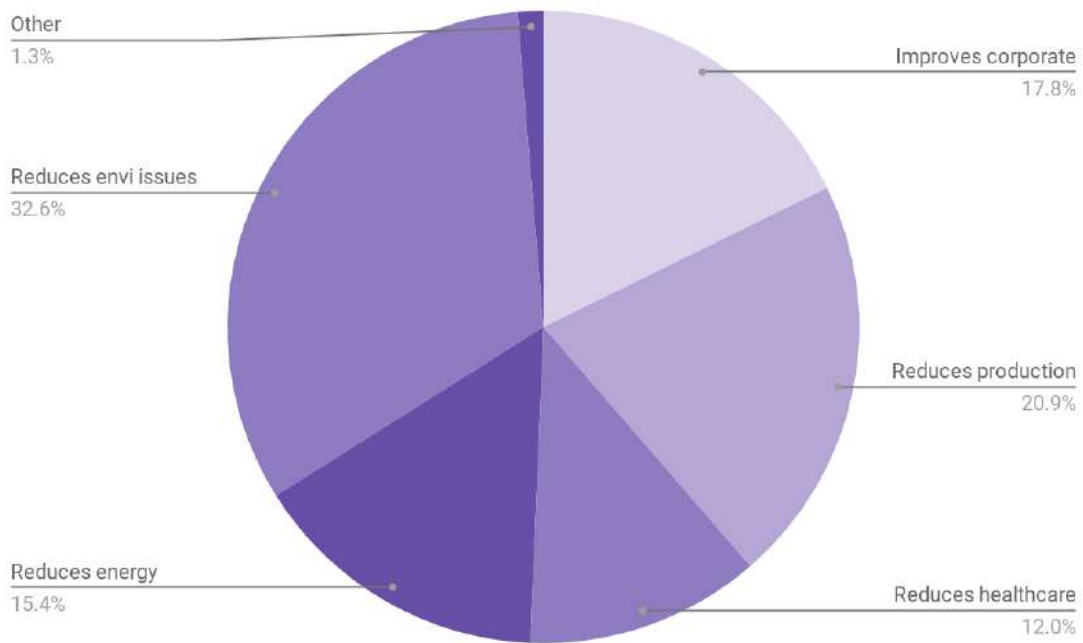
vi. Best Environmental Practices to reduce U-POPs is ...

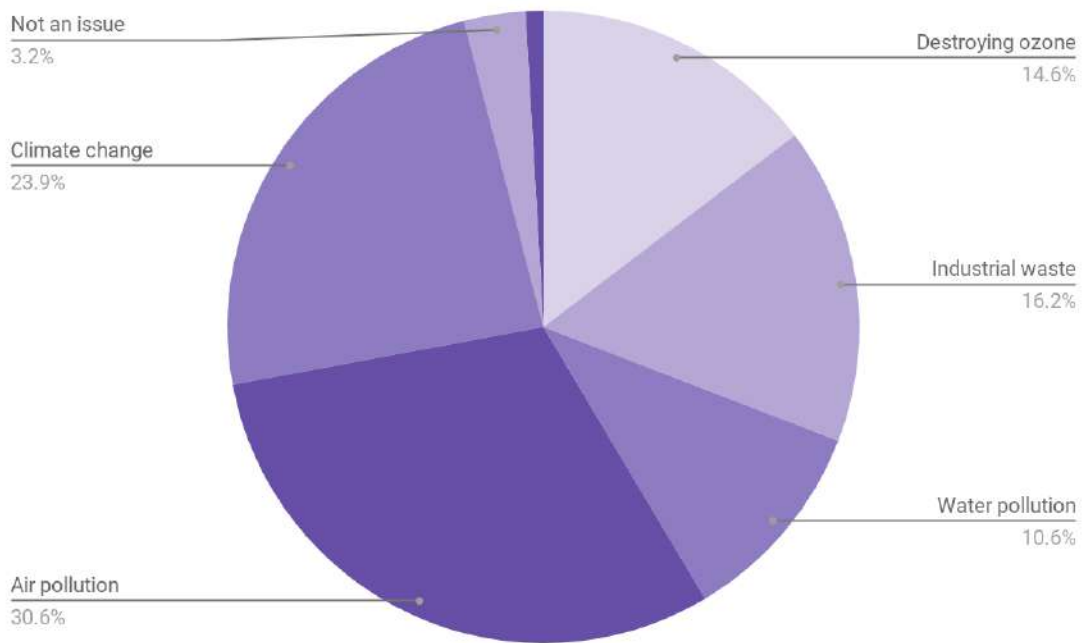

- What do you expect if your business implements BAT/BEP?



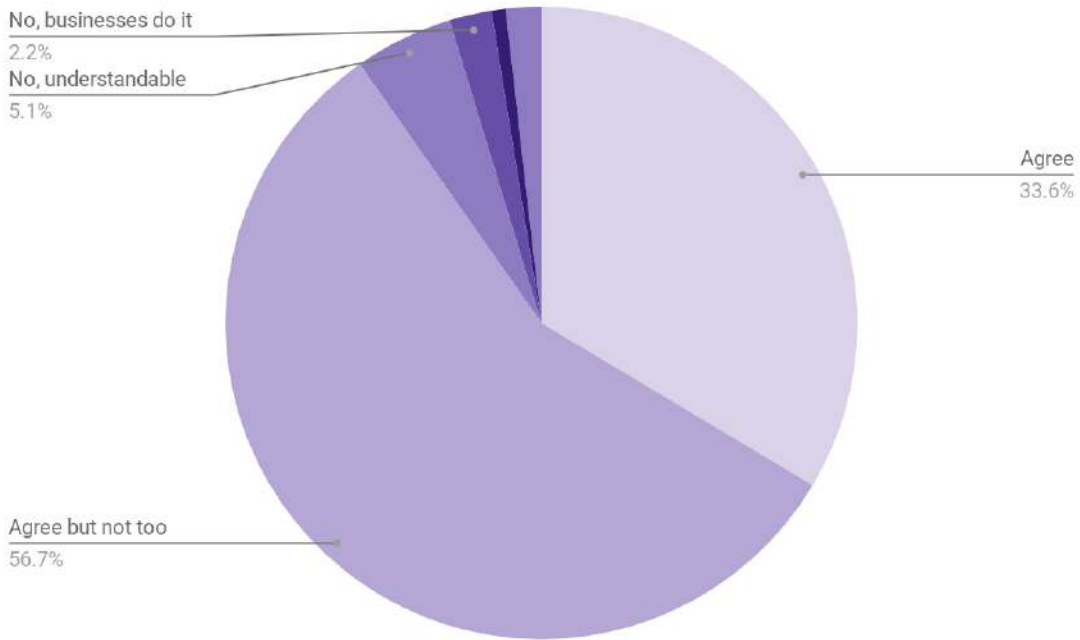

- How metal recycling facilities impact the environment?



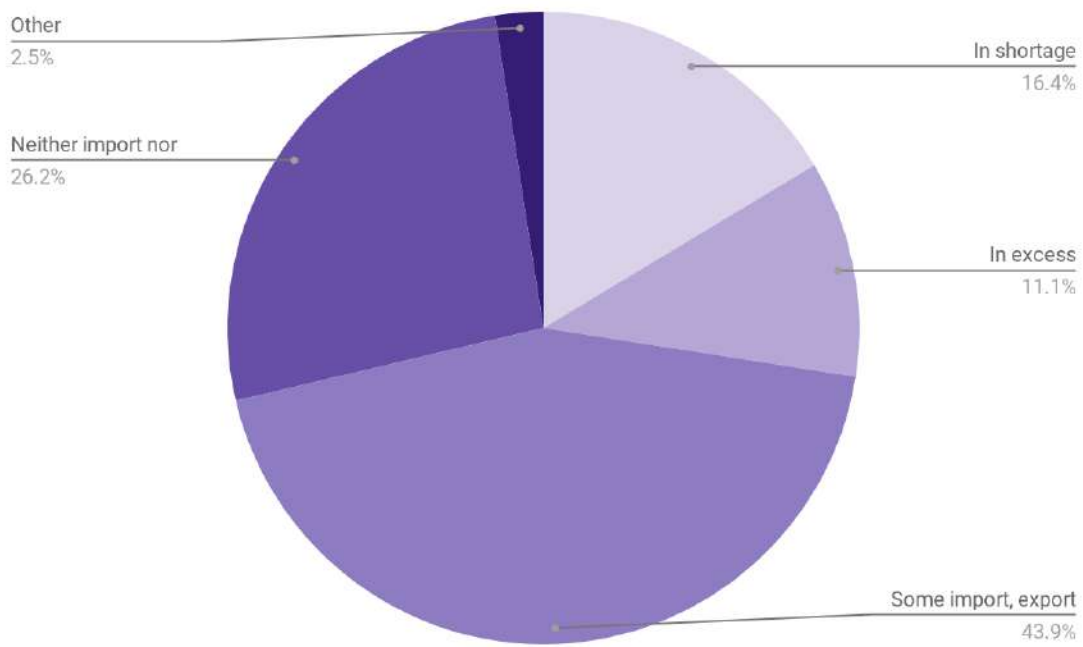

- How do you feel about stricted environmental inspection?



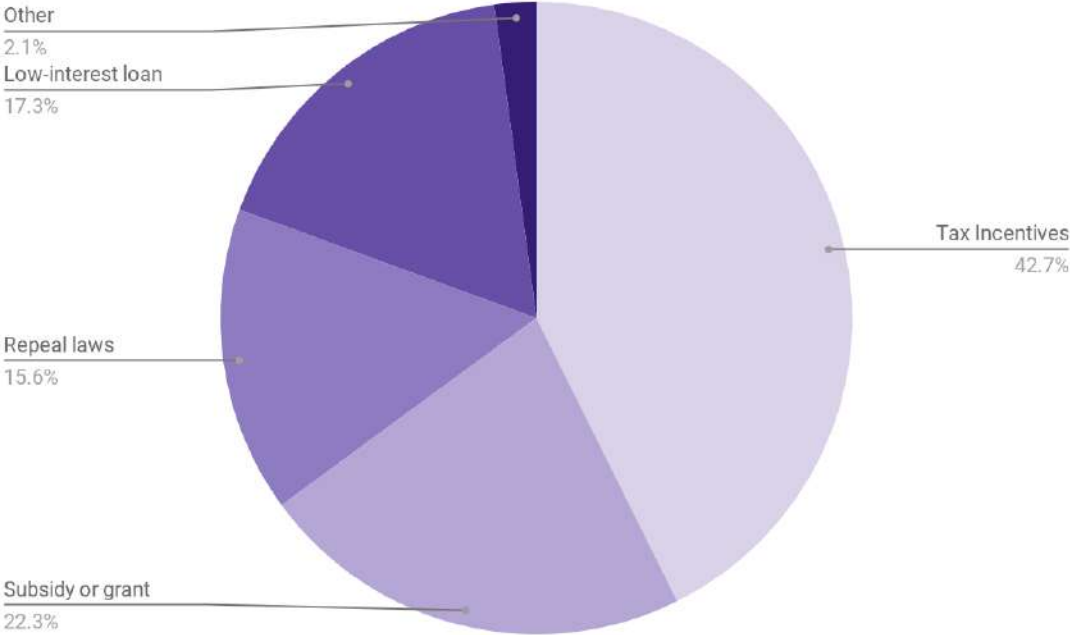

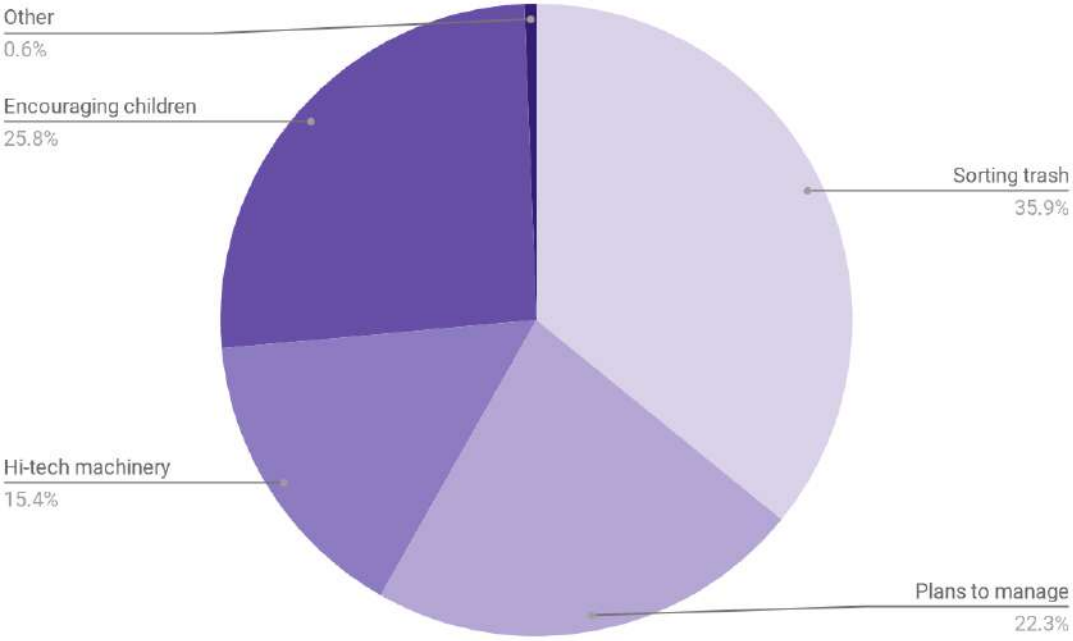

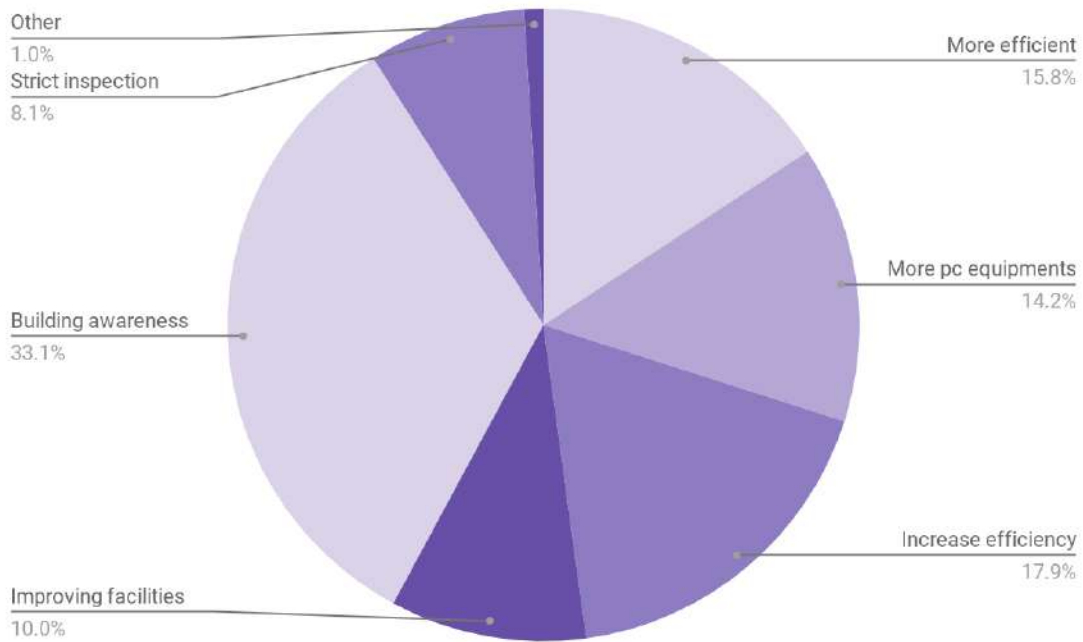
